HOW TO REGISTER

In order to register you will need to be a Bank of Sydney customer with at least one account which can be accessed through internet banking. We require that you are an **account holder**, or have been authorised by an account holder, and have the authority to operate these accounts individually. If you do not have individual authority you will not be able to transact via Internet Banking.

Internet Banking is available for all accounts. (**Please Note:** For some accounts, "access is by way of enquiry only")
